Great new facility on the LDS website (from Pam Hamlyn)

- Enter a place to search, you get a map of England and a clickable link that tells you which County it is in.
- Click on the link and you get information about the place and a blown up map showing surrounding parishes

HARD LABOUR AT MT. EDEN JAIL

Some of the earliest parts of Mt Eden's Prison's history came to light recently providing an archaeological snapshot of the site dating back to the 1850's.

Investigations carried out by archaeologists have revealed evidence of the 1858 wing of the original stockade, which occupied the site before the prison was built. Evidence uncovered included stone piles that were the bearers for the wooden floor of the two-storeyed building, as well as an unusual basalt block structure with curved corners surrounding the building and incorporating an entrance along the northern wall.

The investigation is taking place in preparation for the Mt Eden-ACRP Prison Development by the Department of Corrections. The main prison building is registered Category 1 by the NZHPT and much of it will be preserved and kept in use as an administration centre.

"Evidence of the stockade emerged after the gymnasium building was demolished. We found a very distinctive layer of fill under the floor including a white plaster mixed with wood fragments, a large

number of nails and an assortment of artifacts," says archeologist Rod Clough of Clough and Associates.

"These appear to relate to the early stockade and its demolition. The stockade originally housed the worst of Auckland's offenders from 1856, and then the rest of Auckland's prison population from the Queen Street Jail when it closed in 1866."

Artefacts recovered at time of writing include a bone toothbrush with a 'government issue' arrow scratched into the handle, a bullet and a clay pipe manufactured by Balme in London.

"The owner must have placed considerable value on his pipe, as the stem appears to have been smoked down to the last 2 centimetres," he says.

The excavation also revealed a dense layer of basalt flakes – probably relating to the construction of the later prison wing during the early 20th Century.

"The different layers effectively illustrate the story of the site, from the stockade days through to the construction of the actual Mt Eden Prison building over a century ago," says Rod.

Investigations have so far included photographic and architectural recording of some of the small buildings – including the gymnasium and 'bag shop'. Future work will be targeted towards identifying the original fence line around the stockade and other parts of the stockade that may have survived the building of the later prison.
